With reference to this office tender notice issued vide F.No GOAF/I(20)/55/2023 dated 23.06.2026, open tenders are invited for purchase of **RECTIFIED SPIRIT OF PHARMACEUTICAL GRADE** from established/ reputed manufacturers or their authorized agent/distributors as per specification enclosed with the Tender Documents.
2. Last date for uploading of tenders is up to 15:00 Hrs. of 14.07.2026. Tenders uploaded after due date, time and not in prescribed tender document will not be considered. The tenders are to be submitted (Uploaded) in the prescribed Tender Documents, in respective covers.
3. Tenders uploaded upto prescribed time and date will be opened on 15.07.2026 at 15.30 Hrs.
4. Technical Bid in Annexure C and Financial Bid in the prescribed format as per BOQ shall be duly filled in and signed by the authorized signatory and uploaded online by the bidder in Cover-I along with scanned copies of the following documents:

- (i) Tender Acceptance Letter in format given in Annexure-D, duly filled and signed.
- (j) Certificate of Analysis, duly seal and signed, from the manufacturer from where supply is to be made or complete specification of offered material or Acceptance of Annexure-A duly seal and signed.
- (k) EMD or certificate regarding waive off EMD like MSME,etc. EMD to be submitted, in original.
- (l) Terms & Conditions, duly sealed and signed, in token of proof of acceptance.

5. In case the tenderer fails to submit any of the documents as stated above, Financial bids of the bidder shall not be considered for opening and shall be rejected straight away without any further reference.

The Financial Bid (as in BOQ) shall be duly filled in, digitally signed and uploaded online by the bidder.

6. If it is noticed that the goods supplied do not conform to the specification of the order, GOAW, Neemuch shall have the right to reject the materials in part or full. The supplier shall be liable to replace the rejected materials within the stipulated time. Till the replacement is done, the rejected materials shall be lying at the risk, cost and responsibility of the supplier.
7. The bidders shall be required to submit all documents related to Good Manufacturing Practices (GMP) compliance as specified in Annexure-I. Failure to furnish the said documents will result in rejection of the bid.
8. The General Manager, Govt. Opium & Alkaloid Works, Neemuch reserves the right to reject or accept any tender without assigning any reason.

TERMS AND CONDITIONS

1. The bid must contain complete specification of the **RECTIFIED SPIRIT OF PHARMACEUTICAL GRADE** clearly showing compliance with prescribed technical specifications.
2. Since the tenders are invited on Quarterly Rate Contract basis therefore the items/chemical shall be supplied to this works as and when require till the completion validity of Quarterly Rate Contract.
3. The bidder shall be the manufacturer or authorized distributor of the manufacturer and in possession of a valid Drug Manufacturing / Sale Licence issued by the concerned State FDA/Drugs Control Authority.
4. The bidder/manufacturer must possess valid Excise Licence for manufacture/sale/supply of RECTIFIED SPIRIT and valid RS-7 Licence (or applicable licence) for handling and supply of RECTIFIED SPIRIT, wherever required.
5. **ONDLS Registration – Statutory Compliance**
In compliance with CDSCO / Ministry of Health & Family Welfare directives, the actual manufacturer of RECTIFIED SPIRIT must be registered on the ONDLS (Online National Drugs Licensing System) Portal.
 - Submission of valid ONDLS registration certificate of the manufacturer is a mandatory pre-qualification requirement.
 - Non-submission shall render the bid non-responsive and liable for rejection.
6. In case the bidder is not the manufacturer, a valid authorization letter from the manufacturer, along with complete statutory documents of the manufacturer, shall be submitted.
7. Each consignment shall be accompanied by Certificate of Analysis (CoA) from the manufacturer's approved laboratory, Batch number, manufacturing date, and expiry/retest date.
8. The supplier shall comply with all applicable Drugs & Cosmetics Act, Excise Laws, CDSCO directives, and Government instructions issued from time to time.
9. The basic price on F.O.R. (Free on Rail/Road) GOAW, Neemuch basis and GST/other taxes should necessarily be indicated in the price bid. No any other charges shall be paid by this office.
10. The rates offered will remain valid till the completion of supply of entire quantity of the store and till the validity of Quarterly Rate Contract. Conditional tenders shall not be accepted.
11. **Copies of the documents in support of Good Manufacturing Practices (GMP) compliance, as specified in Annexure-I, must be submitted along with the bid. Submission of these copies is a mandatory eligibility condition for consideration of the bid and bids not accompanied by the requisite copies shall not be considered for evaluation. In case the bidder is a trader, authorized dealer, distributor or sub-dealer, the required GMP compliance documents shall be furnished from the original manufacturer.**

Failure to submit the requisite copies of GMP compliance documents as per Annexure-I at the bid stage shall result in outright rejection of the bid. Such rejection shall be final and binding, and the bidder shall have no right to raise any claim, representation,

protest, objection or legal proceedings on this ground whatsoever.

12. In case, the tenderer withdraws his offer or in the event of tenderer failing to execute, after his tender is accepted, the Earnest Money Deposit furnished by him shall be forfeited without any prejudice to other rights of Govt. of India under any law.
13. In the event of tender being accepted, the Quarterly Rate Contract will be placed by the Competent Authority of Govt. Opium & Alkaloid Works, Neemuch, thereafter a separate supply order along with excise permit will be issued, on as and when required basis. Delivery shall be made after performing necessary excise formalities.
14. The successful tenderer to whom rate contract is issued, shall have to furnish Security Deposit in the form of Account payee Demand Draft drawn in favour of Assistant Chief Accounts Officer, Govt. Opium and Alkaloid Works, Neemuch/ Bank Guarantee/ Fixed Deposit Receipt from a commercial bank at the rate of 5% of the total value of the contract. Such Security deposit should remain valid for a period of sixty days after the successful completion of the supply.
15. In case of delay or failure to execute the Supply Order (s) against the contract, the General Manager, Govt. Opium & Alkaloid Works, Neemuch without prejudice to any other right, under laws, shall have the option :
 - a) To recover liquidated damage (LD) of the value of stores which is not delivered or delayed shall be recovered as follows :
In case of the delivery of stores or any installment thereof is accepted after expiry of the original delivery period, the GM may recover from the supplier the LD equivalent to 0.5(Half) percent of the prices of any portion of stores delivered late, for each week or part thereof of delay. The maximum LD shall not exceed 10(Ten) percent of the value of delayed goods.
 - b) To purchase from other sources at the risk and cost of the supplier to extent of material not delivered.
 - c) To cancel the Supply Order without any liability on G.O.A.W.
 - d) To blacklist and debar the company from making any future supplies to any Govt. Department / PSU of Govt. of India.
16. In case of exigencies, unforeseen circumstances, the Competent Authority of GOAW, Neemuch reserves the right to cancel the supply order for whole or the balance quantity or part of it by way of notice without assigning any reason, what-so-ever.
17. Legal proceedings, if any, emanating from the Quarterly Rate Contract/Supply Order shall fall within the jurisdiction of the competent court of Neemuch as the case may be.
18. The stores when received at the delivery place / destination shall be inspected for its quantity and quality. The ordered material shall be supplied in such a manner so as to withstand hazard of transit and retain specified quality of the dispatched goods.
19. No advance payment on any account shall be made for the supply. After inspection of the material supplied and on the material found satisfactory, payment shall be released by way of PFMS.
20. The material can be inspected at the premises of manufacturers / suppliers by the officers of this organization to ensure the quality of the material as per specification.
21. The competent Authority also reserve the right to increase or decrease the quantity of chemical/material to be supplied based on assessment of the final requirement & tenderer agrees to supply such revised quantities at the same rates and terms of this tender. The

quantity mentioned in the tender document is indicative and subject to variation based on actual requirements during the validity of the Quarterly Rate Contract (QRC). In the event that the entire quantity is not lifted by Govt. Opium & Alkaloid Works, Neemuch (MP) during the QRC period, the tenderer shall not compel or pressurize the Works to lift the full quantity indicated in the tender. The decision of the General Manager, Govt. Opium & Alkaloid Works, Neemuch (MP), in this regard, shall be final and binding on the tenderer, and no claims, whatsoever, shall be entertained for the un-lifted quantity.

22. The Quarterly Rate Contract (QRC) for the supply of **RECTIFIED SPIRIT of PHARMACEUTICAL GRADE** may be extended for a further period of up to 22 days beyond its original expiry date, on the same rates, specifications, and terms & conditions as stipulated in the original QRC, subject to mutual consent of both the purchaser and the supplier.
23. The bidder shall be solely responsible for compliance with all applicable Central / State Excise laws, including obtaining manufacturing, storage, export and transit permits. Import permit shall be arranged by the buyer as per statutory provisions. Submission of licences does not absolve the bidder from obtaining statutory permits for each consignment. Buyer shall not be responsible for non-compliance by the bidder with Excise laws at the exporting State.
24. **Validity of Bids:** The Bids should remain valid for 90 days from the date of Financial bidopening.
25. **Rejection of Bids:** Canvassing by the Bidder in any form, unsolicited letter and post-tender correction may invoke summary rejection. Conditional tenders will be rejected. Non-compliance of applicable General Information and Instruction will disqualify the Bid.
26. If any tenderer submit more than one technical and /or financial bid, the bid would be liable to be rejected out rightly.
27. Canvassing for obtaining tender will be disqualified the bidder from tender process.
28. As this is the tender of QRC, rates should be valid for three months from the date of finalization of rate contract.
29. Successful bidder shall ensure the necessary excise formalities at the time of supply. Excise formalities regarding import will be made by this office and respective documents will be provide to suppliers at the time of supply of material.
30. Successful bidder must ensure to submit GST return in time. Bidder shall declare invoices in their GSTR-1 return and shall pay the tax to the Government by filing GSTR-3B or any other return/form for payment of tax so that bidders invoice details appear in GOAW, Neemuch GSTR-2A return. In case of non-payment of tax or non filing of GST return, tax amount will be recovered as per the decision of competent authority of GOAW, Neemuch.
31. The EMD as mentioned in annexure-G in the form of A/c payee demand draft, fixed deposit receipt, Bankers cheque or Bank guarantee from any of the commercial Banks drawn in favour of Assistant Chief Accounts Officer, Govt. Opium and Alkaloid Works, Neemuch (except Micro and small enterprises (MSEs) as defined in MSE procurement policy issued by department of Micro, Small and Medium Enterprises (MSME) or registered with the Central Purchase Organisation or the concerned Ministry or department) must be accompanied along with duly signed terms and conditions and self declaration.

The EMD of successful bidder shall be released after furnishing of Security deposit at the earliest. The EMD of unsuccessful bidders shall be released at the earliest after expiry of

the final bid validity and latest on or before the 30th day, after the award of the contract. No interest shall be payable on the EMD amount.

32. Force Majeure clause.

- (a) Neither party shall bear responsibility for the complete or partial non- performance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of goods under the provisions of the present contract), if the non-performance results from such Force Majeure circumstances as Flood, Fire, Earth Quake and other acts of God as well as War, Military operation, blockade, Acts or Actions of State Authorities or any other circumstances beyond the parties control that was not known earlier and have arisen after the conclusion of the present contract.
- (b) In such circumstances the time stipulated for the performance of an obligation under the present contract is extended correspondingly for the period of time of action of these circumstances and their consequences.
- (c) The party for which it becomes impossible to meet obligations under this contract due to Force Majeure conditions, is to notify in written form the other party of the beginning and cessation of the above circumstances immediately, but in any case, not later than 5(Five) days from the moment of their beginning.
- (d) Certificate of a Chamber of Commerce (Commerce and Industry) or other competent authority or organization of the respective country shall be a sufficient proof of commencement and cessation of the above circumstances.
- (e) If the impossibility of complete or partial performance of an obligation lasts for more than 6 (six) months, either party hereto reserves the right to terminate the contract totally or partially upon giving prior written notice of 30 (thirty) days to the other party of the intention to terminate without any liability other than reimbursement on the terms provided in the agreement for the goods received.

33. REGISTRATION

- a. Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: <https://eprocure.gov.in/eprocure/app>) by clicking on the link "Online bidder Enrolment" on the CPP Portal which is free of charge.
- b. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.

These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced seQRCh for tenders, wherein the bidders may combine a number of seQRCh parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to seQRCh for a tender published on the CPP Portal.
- ii. Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- iii. The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

PREPARATION OF BIDS

- a. Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- b. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of

documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.

- c. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. - d. - vi. The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.
